Dear Terrier Families,

Welcome to perhaps the strangest school year ever! We are off and running with a few hiccups, but we are working hard to ensure that all families and students are connected. Thank you for your patience as we get technology squared away. All students should have WSD issued iPads and for those with connectivity issues, a hotspot. Clark County continues to bounce back and forth between the moderate to highrisk categories for opening schools. Our school has further complicating factors in that we serve students from all over the state. Transporting students in and out of Clark County on a weekly basis remains problematic due to different counties being in different phases. Our school will remain virtual through at least Oct. 30. Depending on the status of Clark County and discussions with the Department of Health, we may make the decision to extend that. We will share information with families as we have it.

Our campus will be going through a major change in 2021. If all goes as planned, we will demolish four buildings that run down the center of our campus: Epperson, the Red Barn, the old boiler plant and the old cafeteria. These buildings have long been closed and at least one is deemed hazardous, as it is not earthquakesafe. We will begin the pre-demolishment work in October and hope to have all abatement and mitigation done by spring of 2021. The demolishment of these buildings will make our campus safer and provide space for a new academic building in the future.

I hope all of our families are staying safe. The staff and I miss seeing our students in person. Please feel free to reach out to me with questions or concerns.

PBIS: Changes in Approach J.Piper Gallucci, Teacher & MTSS Coordinator

The Washington School for the Deaf adopted the Positive Behavior Supports (PBIS) in 2011. PBIS provides a framework for school-wide expectations and instructional approaches to support student academic and social success. In order to better support our students' diverse needs WSD integrated a variety of supports. This multi-tiered approach is referred to as the Multi-Tiered System of Supports framework.

The PBIS committee formally adopted the Multi-Tiered System of Supports framework and the committee is now called the MTSS Committee. Our district's MTSS framework includes: PBIS, Love and Logic, Trauma Informed Response, Anti-bias education, and Bully Prevention.

In other news, WSD actively recognizes student success in a variety of ways from immediate recognition during class to our monthly Student of the Month assembly. Greetings Terrier Nation from the Student Life Department!

We can all agree that the year 2020 is like no other and we have found ourselves at the start of the school year with remote learning for our students with our staff.

The residential department at WSD is still running with "Virtual Cottages" in place and our Student Life Counselors (SLCs) are geared up to help promote well being of our Terrier students. The SLCs are working with the academic department to help ensure we provide our students the best path to navigate the way ahead to the future.

What we can offer is support to the parents/guardians in various ways while also being there for our students to help/support in any way possible.

We do offer a Virtual After School Program (VASP), cottage meeting/social time, study hour(s), Virtual Independent Living Skills (VILS), and hopefully soon a campus wide social night on a weekly basis.

Our Virtual After School Program runs Monday through Friday from 4 PM to 5:30 PM. VASP offers such activities such as but not limited to exercising, art, cooking for various age groups, story time and even fishing!

Each cottage has SLCs ready to help out with students. The cottages have regular meetings with the students who are assigned to them (both residential and day students), have nightly study hours starting at 6:30 pm, and some cottages have more study time set aside to meet the needs of our students. SLCs are available as resources for the parents/guardians to gather information and also can help tutor our students on a 1 to 1 basis. Please feel free have some face to face time with the SLCs through Video Phones or Zoom.

We also offer the Virtual Independent Living Skills to our Junior and Senior classes every Monday night at 6:30 PM. VILS is a way for our students to engage in learning skills they need to know beyond high school. Such as how to apply for college/trade schools, look for a job, how to rent an apartment or buy a car. The most recent VILS had a guest speaker from our local Deaf advocate center explaining what the regional centers can offer for the Deaf community. It was an opportunity for our students to engage in conversation and discuss the range of services that can be provided. Our other meeting we had was educational for both students and staff alike as we discussed the Air Quality Index. The students were even showing each other and staff different APS on our phones on how to gauge our most recent smoke filled skies. VILS is not a lecture type of class but instead engages our students to put forth ideas and glean some knowledge from those with experience. I am looking forward to seeing what our VILS dinner nights will look like. Be prepared! Your own kitchen will be used by your aspiring chef!

SCHOOL VACCINE REQUIREMENTS



SCHOOL VACCINE REQUIREMENTS Distance Learning during COVID-19



The Department of Health and Office of Superintendent of Public Instruction feel strongly about the importance of keeping our students, staff, and their families safe and healthy. We understand that during these extraordinary times, there may be questions and concerns about school immunization requirements as we begin this unique school year. This document clarifies state law and our recommendations about immunization requirements and exclusion of students.

For the 2020-21 School Year and K-12 Programs Only

- In light of the pandemic, if a student cannot meet the immunization requirements by the first day of school <u>and</u> a student is fully participating in remote learning, we are not recommending that the school exclude that student from school. The student should be immediately enrolled and served remotely.
- Students should be in compliance when they are back on campus for any reason, including small group learning or extracurricular activities.
- If the student's learning program is at school or only partially remote and the student is not in compliance with immunization requirements, they should be enrolled but excluded from physically attending school.
- As required by current state and federal law, any student experiencing homelessness or living in foster care
 must immediately be enrolled and served, regardless of their immunization status or educational setting.
- Schools should continue to work with the families to bring students into compliance as soon as possible.

Background Information

State laws and rules require compliance with immunization requirements on or before the first day of attendance at school. The purpose of the state immunization requirement is to protect the health of the public and individuals against certain vaccine-preventable diseases. Schools should continue to work to ensure compliance with immunization requirements in state law no matter the student's learning location. This means if a child participates in a school program, regardless of their location including online or remote learning, they must meet school immunization requirements per RCW 28A.210.080.

The Department of Health has communicated with health care providers about the importance of continuing routine immunizations during the COVID-19 pandemic, and many providers have been actively working to get kids caught up on vaccinations. If families don't have a family doctor or nurse, they can find a location that provides childhood immunizations by using the <u>Vaccine Finder</u> or by calling their <u>local health department</u>.

Suggested Messages for Parents and Families

- It is important to keep students up to date on their immunizations. Students who are behind on required immunizations will need to be in compliance <u>before scheduled in-person learning begins</u>.
- Keeping students vaccinated will protect more than just the student. It also protects friends, family, and the community from disease outbreaks, such as measles. We've seen multiple disease outbreaks throughout the state in the past few years, and we don't want to experience another, especially during the COVID-19 pandemic.
- Getting a student in to a health care provider is about more than vaccinations. Well child visits ensure students get continued medical check-ups. These visits ensure the student is healthy and prepared to learn.

Thank you for your continued hard work during this challenging time. Keeping students immunized during the COVID-19 pandemic will reduce the risk for other disease outbreaks, which would further strain the return to in-person learning and the entire community and health care system. Thank you for helping us keep our communities safe and healthy.

MAP Testing

This is the time of year we start planning for our fall district-level testing for grades 2 and up to monitor academic progress in reading, language use, math, and science. We use Measures of Academic Progress (MAP): http://www.nwea.org.

MAP is a computer adaptive test, which means the difficulty of questions is based on how well your child answers all of the previous questions. As your child answers correctly, the questions become more difficult. If your child answers incorrectly, the questions become easier. Ideally your child will answer around half of the items correctly. The score is an estimate of your child's achievement level. These scores are also compared with previous scores at your child's performance levels to determine progress.

Even though MAP is an English-based assessment designed for hearing, mono-lingual students with access to incidental learning opportunities, this is the best tool to date that is accessible, aligns with state standards, and can be used to communicate academic achievement and progress considering your child's current performance levels. This is important to consider when interpreting results. MAP has been adopted and vouched for by many deaf and hard of hearing programs across the country.

Fall MAP testing will begin mid-October and will be administered through Zoom.

While testing can be a stressful time for your child, it will most certainly be challenging to do this remotely. We will need your help to make sure your child is successful. Here are some tips to support your child:

1.Review

- Family toolkit
- Family guide to MAP growth
- Common and remote testing questions

2.Check

Make sure your child's device is ready for testing

3.Get organized

• Find a quiet space for your student to take the test and confirm your technology is working properly.

4. Motivate your child

• Explain how doing their best will help their teachers know how to teach them better.

5. Support but DO NOT help

Encourage your child to stay focused and try their best

6.Celebrate

Congratulate your child and confirm they have completed the assessment.
